1. Who We Are

South Jersey Cultural Alliance (SJCA) is a nonprofit organization that connects, empowers, and advocates for artists, organizations, and communities to promote engagement and investment in the arts and history of South Jersey. Our digital platforms are tools to support cultural development, visibility, and public access to regional arts and heritage.

2. Our Platforms

SJCA currently provides access to:

- **CultureConnect** – a professional-facing platform for artists, cultural organizations, educators, municipalities, and other field professionals to manage profiles, events, and resources.
- **CultureQuest** – a public-facing map and mobile app for discovering cultural destinations, events, and stories across South Jersey.
- **SJCA.net** – our main website offering organizational updates, resources, membership access, and news.

All users must agree to use these platforms in accordance with these Terms.

3. User Responsibilities

By using SJCA platforms, you agree:

- To provide accurate and respectful information in profiles, events, and posts.
- Not to upload or distribute offensive, harmful, or misleading content.
- To respect copyrights and only upload content you have the right to share.
- Not to engage in any activity that disrupts or harms the platform or its users.

SJCA reserves the right to moderate, edit, or remove content that violates these terms or our community standards.

4. Membership and Access

Some platform features (e.g., profile creation, access to resources, or calendar posting) may require a current SJCA membership or partner agreement. SJCA offers both paid and free membership levels. Members must keep their contact information up to date and comply with usage guidelines.
